**MAIL BALLOT VOTING AVAILABLE FOR ALL ELECTORAL AREAS**

Qualified electors may vote by mail.

**REQUESTING A MAIL BALLOT PACKAGE:**

Before 4 pm on October 13, 2022 you must complete an application to vote by mail and the application must be submitted to the Regional District office #300, 4545 Lazelle Avenue, Terrace, BC V8G 4E1. The application to vote by mail is available by telephone 250-615-6100, toll free 1-800-663-3208, fax 250-635-9222, email [info@rdks.bc.ca](mailto:info@rdks.bc.ca) or on our website [www.rdks.bc.ca](http://www.rdks.bc.ca).

The following information is required:

1. Full name
2. Residential address
3. Address of the property in relation to which you are voting (for non-resident property electors)
4. Method of delivery of your mail ballot package:
  - (a) pick up at Regional District office
  - (b) regular letter mail through Canada Post to residential address, **OR**
  - (c) regular letter mail through Canada Post to alternate address that you provide when requesting the ballot package
5. If you are not on the list of electors, to ensure you receive the correct registration application form in your package, you must indicate whether you are going to be registering as a resident or non-resident property elector.

The Regional District will send out mail ballot packages commencing on or about September 29, 2022. To be counted, your mail ballot must be received by the Chief Election Officer no later than 8 pm on Saturday, October 15, 2022.

**Elector Registration**

**Resident Electors**

If you are not on the list of electors, you may register at the time of voting by completing the required application form available at the voting place.

To register you must meet the following qualifications:

- 18 years of age or older
- Canadian citizen
- Resident of BC for at least 6 months immediately preceding voting day
- Resident of OR registered owner of real property in the electoral area for at least 30 days immediately preceding voting day, and
- Not otherwise disqualified by law from voting

**Resident electors** will also be required to produce 2 pieces of identification (at least one with a signature). Picture identification is not necessary. The identification must prove both residency and identity.

**Non-Resident Property Elector**

A person who is not a resident of the applicable Electoral Area, but who has been a registered owner of real property in the applicable Electoral Area for at least 30 days before General Voting Day may register as a non-resident property elector. Non-resident property electors will be required to provide evidence of ownership of the real property and the written consent of a majority of the other property owners (if any) that they are entitled to register for the jointly owned property. If there is more than one registered owner of real property either as joint tenants or tenants in common, only one of these individuals may register as a non-resident property elector.
